4.3 MLITSD Visit March 2025

- A recommendation to post information on Ergonomic Assessments was made on April 10th, 2025, by the committee.
- Ergonomic Assessment reports were made available to staff in the area via posting on the Health and Safety boards.
- JOHSC members were advised that this material was posted on April 16th, 2025.
- UWOSA rep noted the importance of review of risk assessments and procedures to be current with worker tasks.

5. Review and Assess Trends

5.1 Accident/Injury Report

• Reported incidents 2025, 148 incidents have been reported on campus: 95 First Aid related incidents, 18 Lost Time related incidents, 28 Health Care related incidents and 7 Near miss/Hazard reports.

- The committee reviewed 24 incidents that occurred in April.
- Committee discussion on an incident report involving use of cleaning products
- Monthly incident rates were compared to historical data (3- and 5-year averages) for this month on campus.
- Section 52 notices were reviewed

- A summary of inspections completed Apr 4th May 2nd, 2025, were made available to the committee.

 - 6 items were issued corrective for action by units from the recent inspection cycle.

 - Assignees for the past due items have communicated progress of corrective actions or HSW has had follow up review.

6. New Business

6.1 Annual Report – Audit Committee

- AVP, HR, advised that the 2024 annual report from Health Safety and Employee Well-Being was presented to the University Audit Committee in April 2025.
- The report was made available for JOHSC members to review
- Western's Lost Time Injury rate was below the 3-year average for the Ontario post-secondary sector.
- University leadership will support the use suspension of operations procedures or locking out specific activities for non-complaint research laboratory areas with repeated or severe unsafe conditions.
- Committee discussion related to the smoke free campus policy and ongoing strategies to maintain compliance.

6.2 Social Science Building

- A building emergency that resulted in a fire occurred on April 24th, 2025, in the Social Science Building.
- This incident displaced academic exam activities.
- The building was closed from normal occupancy to allow for cleanup of damage to ensure conditions would be suitable to return to operations.
- Third party contractors were engaged to complete remediations and health and

- safety assessments. Assessments included designated substance reports, indoor air quality, structural integrity, and water damage.
- Partial occupancy was allowed on May 2nd, 2025, and full occupancy occurred on May 5th, 2025.
- Special arrangements were made for select groups made with units to ensure continuity of operations for areas with unique research.
- Facilities Management is developing plans to complete the reconstruction of damaged areas once initial remediation is finalized.

6.2 Hardscape repairs

- A number of projects will be completed in the summer of 2025 replacing infrastructure and repairing areas of campus.
- Some areas that will be impacted include UCC / SSC, Perth Drive and South Valley / Alumni parking areas as a result of early works for projects or replacement of end-of-life infrastructure.
- Where practicable notices related to disruptions of service will be provided to members of campus who are impacted by projects or scheduled repairs.
